**2023-09-020:** A-1 Recovery, North Little Rock, Terry Wyatt. Ruling; Dismissed with no overcharge. Motion by Cochran, second by Edwards. Motion carried 5-1. Brown opposed.

**2023-01-002:** A-1 Recovery Towing of NLR. North Little Rock, Terry Wyatt. Ruling; \$3,500 Civil Penalty and full restitution for bill \$3,093.38. Motion by Vint, second by Edwards. Motion carried 6-0.
